OPEN FORUM

Kirsten Johnson gave an update on County Council matters: The request for a Public Enquiry into the route of the Oxford/Cambridge Expressway, Rural transport matters and the continued issues around the Holton Village Green, awaiting an update from Vanessa Buckley. Super Users are village people who have been trained to check on the road defects and pot holes and report back to the CC where the works will then be given priority. The Clerk to get more information on this scheme and advertise in the village magazine for an interested villager to take on this role.

Councillors raised the issue of the poor state of the village road surface from the Green to the Pond Farm end of the village. This was not included in the road resurfacing carried out in the rest of the village. Highways to be contacted and a request for this to be included in the re-surfacing schedules.

John Walsh discussed the Terence House Planning Application and the forthcoming Planning Committee Meeting, the Oxford Brookes application and other current applications.

Paula Hood representing Wheatley Parish Council presented the views of WPC on the Brookes planning application and expressed grave concerns over this application.

• The two vehicular access routes will create dangerous road conditions one through the school access point and the other onto the Waterperry Road. The current infrastructure is already congested and dangerous in places.

- The development would inflict serious material harm to the openness of the Green Belt.
- The proposed number of dwellings is contrary to SODC's emerging local plan
- The proposed built area is excessive and to the detriment of historic Holton Park, the listed buildings and parkland.
- Loss of sports pitches and facilities
- Facilities in Wheatley unable to cope with the extra demand

John Fox reported on the Neighbourhood Plan and the opposition to the numbers of dwellings proposed and the area of land to be developed.

Holton Parish Councillors discussed with the Wheatley representatives, the various issues of common concern raised from the Brookes Planning Application .

Holton Parish Council then went back into the meeting to discuss the Planning Applications and brought forward Item 10 to accommodate the visitors from Wheatley and the District Councillor

P17/S3715/FUL. Terence House, Holton. OX33 1PS Amendment No 2.

Variation of Condition 2 of Planning Permission P14/S3212/FUL to move the building 1.8 m closer to NW boundary. Amplified by GCN Licence and amended plans received 20th November 2017.

Amendments to approved pool/garage building under planning permission P14/SO338/FUL. (Erection of a four bedroom dwelling with ancillary pool/garage) (As amended by Design and Access Statement received 22 November 2015)

Application for outline planning permission for single dwelling house for a farm worker

Holton Parish Council recommend Refusal as inappropriate development in the greenbelt.

P18/S0085/PAR. Church Farm, Holton. OX33 1PR

Change of use of two agricultural buildings and land within their curtilage into three dwelling houses.

Response of the Parish Council – To our knowledge the buildings have not been used for agricultural purposes for a long time and cannot be classed as agricultural buildings.

P17/S4254/O (Outline) Oxford Brookes University, Waterperry Road, Holton. OX33 1HX.

Outline planning application, with all matters reserved for subsequent approval except details of vehicular access, for demolition of all existing structures and redevelopment of the site with up to 500 dwellings and associated works including; engineering operations, including site clearance, remediation, remodelling and deposition of inert fill material arising from demolition on site; installation of new and modification of existing services and utilities; construction of foul and surface water drainage systems, including SUDS; creation of noise mitigation bund and fencing creation of public open space, leisure, sport and recreation facilities including equipped play areas; ecological mitigation works; construction of a building for community/sport use and associated car parking; construction of internal estate roads private drives and other highways infrastructure and construction of pedestrian footpaths.

Holton Parish Council recommend **Refusal** of this Planning Application for the following reasons:

Speed survey has been completed and the results show that at most of the locations average speeds are a little above the recommended 24 mph for a sign only 20 mph speed limit. As the degree of excess is for the most part modest, one option might be to consider adjusting the start of the 20 mph - particularly at the south eastern end of the road – and to consider the use of supporting measures such as the use of carriageway roundels.
